CAPTAIN MERVYN SHARP BENNION, UNITED STATES NAVY, DECEASED. Born on the 5th of May, 1887, at Vernon, Utah, was awarded the Medal Of Honor for conspicuous devotion to duty, extraordinary courage, and complete disregard of his own life, above and beyond the call of duty, during the attack on the United States Fleet in Pearl Harbor, Hawaii, by Japanese Forces on the 7th of December, 1941, after being mortally wounded, Captain Bennion evidenced apparent concern only in fighting and saving his ship, and strongly protested against being carried from the bridge.

The hotel is situated next to Salt Palace Convention Center and across the street from The Delta Center sports arena--home of the NBA Utah Jazz. Underground parking is available with unlimited involt privileges at \$6 per car per day for overnight guests, \$9 per day for valet parking. Daily attendees pay \$4 per car for up to 16 hours. There is no hotel parking for RVs. The Parking Place could accommodate RVs which is just across the street from the Wyndham. The hotel provides complimentary transportation to and from the Salt Lake International airport. The shuttle runs every half hour from 6am until midnight. Hotel check-in time is 3pm; check-out is noon.

I served in the Navy during World War II. After 11 battles, we were in Tokyo Bay to protect the U.S.S. Missouri while Gen. MacArthur signed the peace treaty ending the war. We left Japan a couple of days later. It was dusk, and as the sun hit the tip of Mt. Fuji, a searchlight drill was sounded. We hadn't lit searchlights (or even had a drill for it) for over three and a half years, so everybody went helter skelter. Then the captain announced, "This is a searchlight drill. Light all searchlights, open all hatches - the war is over!" To this day, I get goose bumps when I tell this story.

We Will Pay Our Respects To Our Gallant Captain. Captain Mervyn Sharp Benion, U.S. Navy, Deceased, Holder Of The

Medal Of Honor.

While we are in Salt Lake City, we will be holding a memorial service for our Medal Of Honor Recipient, Captain Bennion, who lost his life on the bridge of the ship he was commanding during the Japanese attack on Pearl Harbor on the 7th Day of December, 1941. At this memorial service we will also honor all of our U.S.S. West Virginia shipmates who have passed away over the years. This ceremony will be conducted and planned by our most able Chaplain, Jim Downing. The events will take place on Saturday the 28th of August. You will receive final directions at the reunion.

Proclamation by Governor Cecil H. Underwood

Whereas, hostile aircraft of the Empire of Japan launched a sneak attack on strategic military and naval targets at Pearl Harbor and elsewhere on the Island of Oahu, Hawaii, on the morning of December 7, 1941; and,

Whereas, the attack's element of complete surprise resulted in thousands of military and civilian dead and wounded, plus the destruction of a major portion of the United States Navy's Pacific Fleet; and,

Whereas, the Battleships USS WEST VIRGINIA – (BB-48), USS ARIZONA, USS OKLAHOMA, and USS CALIFORNIA suffered major damage through Japanese bombs and torpedoes; and,

Whereas, the USS WEST VIRGINIA was ablaze from one end of the ship to the other; the crew fought the enemy as well as fires while endeavoring to evacuate the wounded for more than 30 hours; and,

Whereas, through the immediate actions of officers and crew of the USS WEST VIRGINIA, skillful damage control avoided capsizing of the ship, and she settled right side up on the shallow bottom; and,

Whereas, although severely damaged and sitting on the bottom of the harbor, the USS WEST VIRGINIA was re-floated, refurbished and served with distinction in several campaigns during the remainder of World War II;

Now, Therefore, Be it Resolved that I, Cecil H. Underwood, Governor of the State of West Virginia, do hereby proclaim *December 7, 1998*, as:

USS WEST VIRGINIA (BB48) DAY

in the Mountain State and urge all citizens to observe the occasion and to display the United States Flag.

In Witness Whereof, I have hereunto set my hand and caused the Great Seal of the State of West Virginia to be affixed.

Done at the Capitol, City of Charleston, State of West Virginia, this the First day of December, in the year of our Lord, One Thousand Nine Hundred Ninety-eight and in the One Hundred Thirty-sixth year of the State.

Remembering the Last Battleship Battle

The early morning hours of 25 October, 1944 marked an historic event for six "old" battleships of the U.S. Navy. The *California, Maryland, Mississippi, Pennsylvania, Tennessee* and the *West Virginia* lined up across the mouth of Surigao Strait. This resulted in the maneuver which is called crossing the "T" and won the Battle for the U.S. Forces. This engagement was the last Battleship-to-Battleship confrontation in history.

A reunion of the Crews who served on the "old" battleships and who fought in this historic battle is being considered for late October 2000, during the 56th anniversary of the Battle of Surigao Strait. This would include men from all six battleships and would be separate from our regular reunions so as not to interfere with our own schedule. However, before we can go further in planning this event, we need to know your interest in such a reunion.

A location has not been selected at this time. A city in the central part of the country would probably be more suitable to most of you. Cities such as Memphis, TN and Austin, TX have been suggested. An Austin reunion would allow us to visit the Adm. Chester Nimitz museum in nearby Fredericksburg, TX. The museum houses plaques commemorating each of the battleships involved in Surigao Strait and other historic items from other naval battles of World War II.


