## Join us in San Diego for the 2013 Reunion

There is still time to register for the 2013 reunion in San Diego, California. As many of you know, for all of the last several years we've thought that every reunion could be our last. We're happy to be hosting another reunion this year and it's good to get back to California after many years. We need to receive the registrations by September 1, 2013 so we can get the attendee count to the various venues that we'll be visiting. Hotel reservations must be made by August 20, 2013 in order to get the group rate. Call 888-233-9527 to make hotel reservations.

### Getting from the airport to the Crowne Plaza Hotel

Getting from the San Diego Airport to the Crowne Plaza Hotel - a distance of about 7 miles - is easy and convenient. After you have collected your luggage simply follow the signs to the TRANSPORTATION PLAZA where a uniformed transportation coordinator will assist you. A taxi cab ride from the airport to the Crowne Plaza Hotel will cost about \$25. Up to 4 people are allowed in one taxi cab.

Shuttle van service is also available at the TRANSPORTATION PLAZA. Super Shuttle charges \$12 per person for a ride from the airport to the Crowne Plaza Hotel. Advanced reservations are preferred. For a shuttle reservation call: 1-800-974-8885. Note that shuttle vans may make several stops to drop off other passengers along the way to the Crowne Plaza Hotel. Both shuttle and taxis services have ADA compliant vehicles.

## That Night at Surigao

This is a new book release by author M. Ernest Marshall, M.D. that features prominently the history of the *U. S. S. West Virginia* (BB-48) during World War II. This book is the result of extensive, multi-year research. The theme of the book is to tell the story of the naval war in the Pacific Theater as it was experienced by a number of individuals and highlights what life was like for those serving on a battleship. Lt. Thomas Lombardi was serving on the *West Virginia* at the time of the Japanese attack on Pearl Harbor. Within a few days after the attack, while memory was sharp, he wrote a detailed after-action memoir of his experiences aboard the ship that day. This memoir was combined with several other after-action reports that were submitted to the Navy Department within days of the attack and with oral histories given by surviving veterans of the "Wee Vee" to tell the stories of the individuals who survived that experience. After being graduated from Dartmouth College, Lt. Robert O. Baumrucker was serving in the Navy Reserve until called to active duty. Although it was expressly against Navy regulations to do so – a court martial offense – he maintained a diary for three years while serving on three different battleships. He served on the *U. S. S. Mississippi*, the *U. S. S. Tennessee*, and the *U. S. S. West Virginia*. While assigned to the *Tennessee*, he participated in the Battle of Tarawa and the Battle of Kwajalein before being transferred to the *West Virginia* while she was still in Bremerton, Washington undergoing repairs and modernization. He served on the *West Virginia* until the war was nearly over. During the Battle of Surigao Strait, Baumrucker was in charge of the 16" guns for the ship and was the first to spot the Japanese fleet on radar and formulate a firing solution that was so accurate that the ship's first salvo struck the lead Japanese battleship. Details of this battle are explored in such a way that the reader has an excellent idea of what it was like to be on the ship as the enemy fleet approached.

The *West Virginia* was struck by a kamikaze plane on the opening day of the battle for Okinawa. Fortunately, the bomb the plane carried did not explode. Details of this strike, damages done, sailors killed, and the fate of the dead Japanese pilot are revealed.

Thousands of pages of Deck Logs, Action Reports, and War Diaries from three battleships, acquired from the National Archives, were explored in support of this book. The intent of the book was to combine the written memoirs, oral histories, and ship's records to paint a picture of what it was like for the men serving on a battleship during WWII in the Pacific Theater. Details of daily life aboard ship are described. The book even explores interpersonal conflicts that arose among various officers on the ship.

Baumrucker wrote a line-crossing book titled, "The USS West Virginia Crosses the Equator – Again." The text of this book explores how he achieved this while performing his other duties as Intelligence Officer and the officer in charge of Main Battery Fire Control for the ship's big guns. A copy of this out-of-print, rare book is included in this text. The book contains many previously unknown details of life aboard ship and a number of previously unpublished photographs.

"That Night at Surigao" is being published by Sunbury Press, Pennsylvania, and will be in print within two weeks. At the 2013 reunion of the USS West Virginia Association, the author will be present with a limited number of books to be sold and to do an author signing.
